Achieve the ACA qualification by successfully completing all components of ACA training:

- professional development;
- ethics and professional scepticism;
- three-five years practical work experience; and
- 11 of the 15 accountancy, finance and business modules.

You are not required to take the ACA Certificate Level Law and Principles of Taxation modules or the Professional Level Business Planning: Taxation and Tax Compliance modules. Instead you will need to study for and successfully complete the equivalent SOEL tax and law modules.

Achieve the SOEL qualification by successfully completing all elements of SOEL training.

Once you become a full member of SOEL, the ACA qualification can be achieved by claiming 11 credits for prior learning and successfully completing four remaining accountancy, finance and business modules.

These modules include the ACA Professional Level Business Strategy and the Advanced Level Corporate Reporting, Strategic Business Management and Case Study.

Step-by-step guide to completing the ICAEW-SOEL Programme

To complete the Accredited Membership Programme and become a member of ICAEW and SOEL, you will need to train for and successfully complete the ACA and SOEL qualifications as part of on-the-job training.

Here is your guide to achieving both qualifications.

1 Register as a student

You can start studying for the Accredited Membership Programme as an ACA or SOEL student. Whichever you start first, be sure to register as a student with ICAEW and SOEL.

2 Apply for credit for prior learning

Credit for prior learning is available towards the ACA and SOEL modules. Check all available credits and apply for CPL at icaew.com/cpl.

3 Start studying

Start your journey by studying towards and successfully completing the ACA and SOEL qualifications. You can start studying the exams straightaway; flexible tuition options are also available.

4 Find a training agreement

To become an ICAEW Chartered Accountant, you will need to complete an ACA training agreement with one of our 3,500+ authorised employers.

5 Be accepted as a member

Once you have successfully completed your ACA training and SOEL exams and are accepted as an ICAEW and SOEL member, you can use the prestigious ACA and OEL letters after your name.

If you are registered as a statutory auditor with SOEL/ELTE then you may apply for audit recognition in the UK under the Statutory Audit Directive (SAD). To apply and for more information, please visit icaew.com/statutoryauditdirective.

If you are not registered as a statutory auditor with SOEL/ELTE, but have gained ICAEW membership under the Accredited Membership Programme, then you may gain audit recognition in the UK by completing additional practical experience and passing additional exams.
